

EVOLLE Slogan Contest Rules & Regulations

Organiser & Eligibility

Duration

Submission of Entries & Qualifying Criteria

1 For every purchase of EVOLLE™ - 35g facial bar from any of our Authorised Dealers listed in our EVOLLE™ Official Website [the Organiser's website] [www.evolle.com], you will be entitled to enter this Contest. The proof of purchase shall be the original EVOLLE™ wrapping silver foil with EVOLLE™ sticker ["the Proof of Purchase"].

2 Each entry form submitted, must be individually and originally filled, complete with the required details, correctly complete the SLOGAN shown in the entry form and must be accompanied with the required Proof of Purchase.
